OUR YOUTH SHELTER OFFERS COUNSELING, LIFE SKILLS TRAINING, EDUCATION, AND OTHER CRITICAL SUPPORT TO TEENS IN CRISIS. YES AND ERC HAVE PROVIDED LIFE-CHANGING SERVICES TO MORE THAN 60 YOUTH OVER THE PAST YEAR. NURTURING CASEWORKERS HELP YOUTH GET BACK TO SCHOOL, RE-ESTABLISH FAMILY BONDS, AND MEET THEIR GOALS. RECENT EVALUATIONS SHOW THAT WE WERE ABLE TO CONNECT 90% OF YOUTH WITH AN EDUCATIONAL PROGRAM OR TUTORING SERVICES. OUR YMCA ASSISTED 240 RESIDENTS IN OUR SUPPORTIVE HOUSING PROGRAM. THIS PROGRAM PROVIDES PERMANENT HOUSING TO CHRONICALLY HOMELESS FAMILIES AND INDIVIDUALS. THIS PROGRAM PROVIDES EACH ADULT

DUE TO COVID-19 AND FOR THE SAFETY OF OUR PROGRAM PARTICIPANTS AND STAFF; WE MOVED THE PROGRAMS TO REMOTE LEARNING PROVIDING THE STUDENTS AND KIDS WITH THE SAME QUALITY LEARNING EXPERIENCE WHILE USING SMART TECHNOLOGIES LIKE ZOOM. THE YMCA IS COMMITTED TO WORKING WITH THE SCHOOL DISTRICTS TO PROVIDE THESE ESSENTIAL PROGRAMS TO KIDS DURING THESE CHALLENGING TIMES.
